Pope sent of the State and District afores<sup>d</sup> in consideration of the sum of four hundred Dollars  
to me Paid by Richard Pope of the said State and District Have granted bargained sold and  
released and by these presents do grant bargain sell and release unto the said Richard Pope  
a plantation or tract of land containing two hundred and fifty acres more or less situate in the  
afores<sup>d</sup> District on the waters of the little grove. Beginning on a maple on a small branch  
thence running straight to a red oak corner it being part of a tract of land James Blackstock  
bought of James Ware thence a straight line to a post oak being part of a tract of land  
the said Blackstock bought of George Vaughan thence to a blackjack near the Trail  
Road and an open line and a straight one thence to a sowerwood on the branch near  
the trail road thence down the said branch to the big fork thence down the little  
grove to the mouth of the said branch the said maple stands on thence up the said branch  
to the Beginning. being part of tract of land originally granted to John Bowie and part of a tract  
of land originally granted unto George Vaughan including two hundred and fifty acres  
more or less. Together with all and singular the rights members hereditaments & appurtenances  
to the said premises belonging or in any wise incident or appertaining To have and To Hold all  
and singular the said premises unto the said Richard Pope His Heirs and assigns and I do hereby  
warrant and forever defend all and singular the said two hundred and fifty acres of Land more  
or less unto the said Richard Pope his heirs and assigns against myself my heirs and assigns  
and all and every other person or persons whomsoever lawfully claiming or to claim the same  
any part thereof. In Witness whereof I have hereunto set my hand & seal this fourteenth  
day of July one thousand eight hundred and six. and in the thirty first year of the
