D. Thomas to the said James Smith & Roger Smith by deed of conveyance herunto annexed bearing date the third day of May A.D. 1808. & Recorded in the Clerk's office in book 16. page 106 & 107. Together with all and singular the rights, members and appurtenances therunto belonging hereby warranting and defending the said premises unto the said James Smith his heirs and assigns against myself & my heirs and against every other person claiming or to claim the same or any part thereof. Know all men by these Presents that I Joseph King of State of South Carolina and Greenville District for and in consideration of the sum of one hundred dollars to me in hand paid by Mykel Cruet of State and district aforesaid Have granted bargain sold and released, and by these Presents do grant bargain sell and release unto the said Michail Cruet, a certain tract or Parcel of land in the district aforesaid on the waters of Tiger called Fatanbergs branch, Beginning on a post oak station on south side of S. Sawney, and running with S. line until it comes on weather square with a small branch from Tillet's mountain, and down the same to its emptying into the big branch which runs through S. land, from thence up a branch called the Millstone branch to a mountain branch on a rock & then along said line to conditional corner on the Myre branch, made between Abner Centee and Richard Wood, thence with the Conditional line to the beginning post oak corner — Containing by estimation fifty acres be the same more or less, it being part of one hundred and thirty acres laid out to Hugh Thompson relapsed by John Gowen and sold to Abner Senter, thence to top,
