Joseph Walker of the state and District aforesaid for and in consideration of the sum
of one hundred and twenty dollars to me paid by Jacob Belw of the said state and district
aforesaid, I have granted, bargained, sold, and released, unto the said Jacob Belw,
and by these presents do grant bargain sell and release a certain tract or parcel
of Land, laying and being in the district aforesaid Being on the branches of the
Beavardam Creek of North tyger river & a branch of greens creek of S. facolats river
Beginning at a red oak 3x and running thence S. 15. E. 48. Ch. 50. links to a stake, thence
S. 58. W. 29. Ch. 50. links to a chestnut, thence N. 55. W. 45 Ch. to a stake, thence N. 57. E. 61
Chain 50 links then to continue to a red oak corner from thence on a conditionally
line now made between the S. Jacob Belw and Joseph Wood from said oak
in his cleared land to continue to a stake on a line running near greens creek thence on
said line to the Beginning corner (all excepting a piece on the Beavardam creek Plat
-ed to Robert Goodgion's land) containing two hundred acres be the same more or less
and was granted to George Inaham by Patent bearing date March 5th 1793. and by him
Conveyed unto the said Brig. Huddleston from him unto the present Joseph Walker
and now unto the said Jacob Belw - Together with all and singular the premises before
mentioned, and appertanances thereunto belonging or in any wise appertaining there
-to - To have and to hold all and singular the rights members, hereditaments & apperta-
-nances to the premises before mentioned and I do hereby bind myself my heirs Exec^r
and administrators to warrant and defend the said premises unto the said Jacob
Belw his heirs and assigns for ever, against me and my heirs, and against every
person lawfully claiming or to claim the same or any part thereof - In Witness whereof
I have hereunto set my hand & seal this twenty eight day of October, one
Thousand Eight hundred & Twelve Signed sealed and Delivered in presence of
