To have & to hold the before mentioned premises with the appurtenancy to the said premises Waddy Thompson his heirs and assigns forever and I do hereby warrant of forever will defend the before mentioned premises unto the said Waddy Thompson his heirs against me my heirs and against the claim or claims of all & Person or persons whomsoever.
