

State of South Carolina: Know all men by these presents that I Page Roark of Spartanburg District in the State aforesaid, Merchant in Consideration of one hundred and sixty dollar, to me in hand paid by John Green of Greenville district and State aforesaid. Have granted bargained sold and released and by these presents do grant bargain sell and release unto the said John Green all that tract or parcel of Land containing sixty four acres be the same more or less, situate in the State P district aforesaid, on both sides of Maple Creek waters of Enore River, Beginning on a history corner on the north side of said creek thence running N. 53 W. 17 chain to a dogwood corner thence N. 25 E. 40 chain, to a red oak corner thence S. 57 E. 17 chain to a history corner thence S. 25 W. 40 chain to the Beginning, which includes the whole intended to be conveyed being part of a tract of land originally granted unto Marget Coote. — Together with all and singular the rights, members, hereditaments and appurtenances to the said premises, belonging or in any wise incident or appertaining. To have & to hold all and singular the sd. premises, before mentioned unto the said John Green his heirs, or assigns forever, and I do hereby bind myself my heirs, Executor, and administrators, to warrant and forever defend all and singular the said premises unto the said John Green his heirs, and assigns, against myself, my heirs, and against every person whomsoever lawfully claiming or to claim the same or any part thereof, Witness my hand and seal this sixth day of January in the year of our Lord one thousand Eight hundred & thirteen, and in the thirty seventh year of American Independance, signed sealed and delivered in presence of. —
