



South Carolina. Know all men by these Presents that I Philip Perry of Greenville District State aforesaid
for and in consideration of the sum of one hundred dollars to me in hand paid by William Blackley of
Greenville District and State aforesaid have granted bargained sold and released, and by these Presents do grant
bargain and sell unto the said William Blackley a Plantation or tract of land lying and being Situate in Greenville
on the banks of bushy creek, waters of sandy river Beginning on a R. & 3+ runs S 30, Ch. to stake thence N 50
to Ch. 3+, N 30 to Stake, then E 50 ch to beginning, including one hundred and fifty acres, be the same
more or less, Together with all and singular the rights members hereditaments and appurtenances to the premises
belonging or in any wise incident or appertaining; To have and to hold all and singular the premises before
mentioned unto the said William Blackley, - And I do hereby bind myself my heirs executors and adm^{rs}
to warrant and forever defend all and singular the premises before mentioned unto the said William Blackley against
myself and my heirs and against every other person whomsoever lawfully claiming or to claim the same or any
part thereof - In Witness whereof I have hereunto set my hand and seal this 2^d September 1813. -

This Indenture made this this twenty seventh day of August in the year of our Lord one thousand eight
hundred and thirteen Between Thomas Tarrant of the State of South Carolina and District of Greenville
of the one part, and Adeline W. Blackley, of the District and State aforesaid of the other part, Witnesses
that the said Thomas Tarrant for and in consideration of the sum of eight hundred dollars to him in hand
paid by the said Adeline W. Blackley, at or before the sealing and delivery of these presents, the receipt
whereof is hereby acknowledged, have granted bargained, sold alienated, released and confirmed to
and by these presents do grant bargain sell alienate, release and confirm unto the said Adeline
W. Blackley her heirs and assigns forever, All that Plantation or Tract of Land containing
two hundred and twenty three acres be the same more or less, lying Situate and being in the district
of Greenville and State aforesaid, being part of a tract of Land originally granted to James Blasingame
Recorded in the Secretarys Office in Grant book W. W. W. W. in page four hundred, bounded by lines, running
N. W. S. W. & S. E. by Joshua Thompson, and N. E. by Merry Hall, land, and hath such Shape form
and marks as the plat hereunto annexed doth represent. Together with all and singular the rights
members hereditaments and appurtenances whatsoever unto the said tract of land belonging or in any wise
incident or appertaining: To have and to hold all and singular the said premises with the appurtenances
therunto belonging unto the said Adeline W. Blackley her heirs and assigns to their proper use & behoof
forever; And lastly the said Thomas Tarrant for himself his heirs executors administrators & assigns
