


and deed deliver the within Deed of conveyance for the uses and purposes
in mentioned, and that William Ford Together with himself were in
the presence of each other subscribing witnesses to the same, sworn to this

279 South Carolina Greenville District. Know all men by these presents
that I Thomas McCarrel of the State and District aforesaid for in con-
sideration of Two Hundred Dollars to me in hand paid by Joshua Hawkins
of the State and District aforesaid have granted sold and released and by these
presents do Grant bargain sell and release unto the said Joshua Hawkins a tract of
Land containing Forty Acres lying and joining a tract of Land where said Haw-
kins now lives being originally granted to Samuel French, it being part of
a tract of Land originally granted to Thomas McCarrel and this part being
conveyed to me by Thomas McCarrel 3rd day of March in the Year 1812 -
Beginning on a Poplar corner thence Fifty Rod a South West course to a red
oak corner thence a straight line a south course to a red oak, thence a south
west Fifty Rod a straight line to a corner crab tree from thence to the beginning
corner Poplar Together with all and singular the rights members hereditaments
and appurtenances to the said premises belonging or in any wise incident or appu-
taining, to have and to hold all and singular the premises mentioned unto
the said Joshua Hawkins his heirs and assigns forever and I do hereby bind my
self my heirs executors and administrators to warrant and forever defend all
and singular the premises unto the said Joshua Hawkins his heirs & assigns against
myself and my heirs and against every other person whomsoever Lawfully claiming
or to claim the same or any part thereof. In witness whereof I have set my hand and
seal this 13th of March in the Year of our Lord one Thousand Eight & Twelve
