sell and Release unto the said Elias Hollaway all that tract or parcel of
land lying and being in the District and State aforesaid on the waters
of Santee River containing three hundred and be the same more or less and
bounded as follows, viz, by lands of John Sony, Jonathan West Elias Hollaway
and Jeremiah Cleveland the three last mentioned names. The land was formerly
held by Shields Booker Archy Mahan, and Judge Pundtton. Together
with all and singular the rights, members, hereditaments, & appurtenances
to the said premises belonging or in any wise incident or appertaining
To Have & To Hold all and singular the premises heretofore mentioned
unto the said Elias Hollaway his heirs and assigns forever and I do hereby
bind myself my heirs, executors and administrators to warrant & for ever
defend all and singular the said premises unto the said Elias Hollaway
his heirs and assigns against myself my heirs and every other person or
persons lawfully claiming or to claim the same or any part thereof.
