

 State of South Carolina Know all men by these presents that I George Green of Greenville District in the State aforesaid in consideration of Eight Hundred Dollars to me paid by David Mosteller of the County of Lincoln in the State of North Carolina have granted bargained sold & released and by these presents do grant bargain sell & release unto the said David Mosteller all that tract or parcel of Land lying & being in Greenville District & in the State aforesaid on both sides of Hamptons branch waters of South Tigr river originally granted unto Issiah Culbertson on the 16<sup>th</sup> day of July in the Year of our Lord one Thousand seven hundred & Eighty four by his Excellency Benjamin Guizard containing two hundred Acres & bounded as follows beginning on a post oak corner running from thence E. 44 Ch. 72 W. to a black oak corner thence S. 44 Ch. 72 W. to a post oak corner thence West 44 Ch. 72 W. to a stake corner thence
