The State of South Carolina, Know all men by these presents, that
Jeremiah Stokes senior of Greenville District and State aforesaid for & in
consideration of One Hundred & fifty Dollars to me paid by Jeremiah
Stokes Junr of the District & State aforesaid, have granted bargained
sold & released & by these presents do grant, bargain, sell and
release, unto the said Jeremiah Stokes Junior all that tract or parcel
of Land, lying & being in the District aforesaid on the North East
Side of Ruddy River supposed to contain about Thirty Acres, be the same
more or less. Beginning at a Stake on the bank of Ruddy River near
Jeremiah Stokes Junior's persimmon corner, thence down the Meanders of
the River to a Black Gum corner on the South west side of said
River, corner to a tract lately belonging to Levi Stokes thence crossing
the said River about a north East course to a post oak corner of the
tract on which the said Jeremiah Junior now lives thence with the
Jeremiah Stokes Junior's line to the beginning persimmon and stake
corner together with all & singular the rights, members, Hereditam-
ents, & appertinances, to the said premises belonging, or in any
wise incident or appertaining to have & to hold all & singular
the premises before mentioned, unto the said Jerry Stokes Junior
his heirs & assigns forever & I do hereby bind myself my heirs,
Executors & administrators to warrant & forever defend all & singular
the said premises unto the said Jerry Stokes Junior his heirs & assigns
against myself & my heirs & against every other person or persons
whomsoever lawfully claiming or to claim the same or any part
thereof witness my hand & seal this sixth day of September One
Thousand Eight Hundred & sixteen. signed sealed & delivered in
