


of a tract formerly owned by Doctor Shelton & conveyed through defendant
hands down to the said Griffin the Land to be conveyed begins on a
pole 2x 3x runs N 30 W. 5.50 to a stake then N 40 E 45 To blacky oak 3x
then S 23 E. 20 Ch to stake then S 48. W 45 to Po 03x then S 21 W. 45 Ch to
Maple on the Branch then down the various courses of said Branch to
the beginning including Eighty all and singular the Rights Members
Hereditaments to the said Premises Belonging or in any way Incident or
appertaining to have & to hold all & singular the Premises before mention
ed unto the said John Chamblee & I do hereby bind my self and
my heirs Executors & assigns to warrant & forever defend all & singular
the Premises before mentioned unto the said John Chamblee his heirs &
