 aforesaid, hath granted, bargained, sold, confirmed, & released, unto
 the said Phillimon Huff all that Tract of land, situate, lying &
 being in the District & State aforesaid, on Saluda River & the waters
 thereof, containing One hundred fifty acres, more or less bounded on the
 West by the said Saluda River, on the north by land belonging
 to A. Huff on the East by land belonging to Silas Holladay & on
 the South by land belonging to William Payne. Together with all & singular
 the rights, members, Hereditaments & appurtenances to the said bargained
 premises. To have & to hold all & singular the said bargained premises unto
 the said Phillimon Huff his heirs & assigns forever. I the said Jonathan
 West do hereby bind myself my heirs & representatives, to warrant & forever
 defend all & singular the above bargained premises unto the said Phillimon
 Huff his heirs & assigns, against myself my heirs & assigns & against
 all & every other person or persons lawfully claiming or to claim the same
