Know all men by these Presents that I George Salmon of Greenville district, and State aforesaid in consideration of the sum of one thousand dollars to John Massey in hand paid by Ruben Valley of the said district, the Receipt whereof is hereby acknowledged, Have granted bargained sold & released Conveyed and confirmed, and by these presents do grant bargain sell release Convey and confirm unto the said Ruben Valley his heirs and assigns all that plantation tract or parcel of land where on the s^d John Massey now lives, containing by estimation two hundred and five acres by the same more or less, situate in Greenville district aforesaid on the northeast side of Chickaroa river waters of Saluda river and runs as follows, that is to say beginning on a water or willow oak on the said river thence north fifty seven degrees east to a post oak, thence North twenty degrees East to a small pine a conditional corner made by the s^d John Massey and Edward Couch, thence with the marked line between the said Massey to what was formerly John Athins, now Buff. Couch line thence south thirty four degrees west with said line to a post oak thence west nineteen chains to a spanish oak thence south forty degrees west twenty four chains to a persimmon on the river bank, thence down the meanders of said river to the beginning the same being a part of two tracts of land granted to myself; Together with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging or in any wise incident or appertaining, To have and to hold all and singular the premises above mentioned unto the s^d Ruben Valley his heirs, & assigns forever, and I do hereby bind myself my heirs, Executors & administrators to warrant and forever defend the above mentioned premises unto the said Ruben Valley his heirs and assigns against myself my heirs, Executors & administrators, & against all and every other person and persons whomsoever lawfully claiming or to claim the same or any part thereof. In witness whereof I have hereunto set my hand & affixed my seal the Thirtieth day of November in the year of our Lord one thousand eight hundred and eighteen.
