 State afores^d has granted, bargained, sold, & released, and by these presents
 do grant bargain & sell unto the said Tho^s Dyer a plantation a tract
 of land lying and being situate in the district & state aforesaid on Linderman
 mill creek waters of Sandy river it being a part of a tract originally granted
 to John Lafida and a part of a tract originally granted to John Linderman
 and conveyed through different hands down to W^m Mayhall the land to
 be conveyed before on page runs S50 W49:75 to stake 3x then S20 E20:75
 to P.O. 3x then S75 W3:90 to R.O. 1x then S55 W17 to Pin stump 3x then S30 W13
 to P.O. 3x then N63 W17 to Spanish O. 3x then N20 E84 50 to R.O. 3x then S50 E
 18:50 to poplar on branch 3x then down s^d branch to poplar on the s^d mill
 creek 3x then down s^d creek to stake at the mouth of branch 3x then up
 the s^d branch to maple 3x then S40 E12 ch^d to the beginning, including
 three hundred & twenty six acres. Together with all and singular the
 rights, liberties, hereditaments, & appurtenances, to the s^d premises belonging
