Beginning on a water oak 3x at the mouth of a Small branch in the survey granted to the said Wm Barnett, thence up the meanders of said branch 37 chs to a black gum 3x thence S 45 E 13 chs and fifty links to a red oak 3x N.W. thence N 33 E 14 chs & 14 lks to a Post o.
