



ents Eli Baldwin for & in consideration of the sum of three
hundred Dollars to me in hand paid by Walter Ashmore have
Granted Bargained and sold unto the said Walter Ashmore a cer-
tain tract or plantation of Land containing one hundred acres more
or less situated in the district aforesaid on the south side of
Reedy River Beginning and light wood stump on the way or
Road thence up the said road to a stake corner thence N. 28
To a maple corner on the rock branch thence down said branch
To a safe as corner thence up the fork of said branch to a
Rock corner thence S. 30 E 27 on Daniel Hidas Land to stake corner
thence S. 25 E 10 to the Beginning together with all & singular the
Rights members hereditaments to the said premises belonging
or in any wise incident thence unto, to have and to hold all
and singular before mentioned premises unto the said Wal-
ter Ashmore his heirs & assigns for ever & I do here by and my
self my heirs & assigns to warrant & ever defend all & singular the
premises unto the said Walter Ashmore his heirs & assigns
& against my self my heirs & assigns & all other persons
Lawfully claiming the same or any part thereof giving
under my hand and seal this the 29 day of December 1818
