and Released and by these presents do grant bargain sell and
Release unto the said Street Thuston a tract or parcel of land
lying and being in the district of Greenville aforesaid on the
south side of the middle fork of Tyger River, Beginning at
a white oak and Running thence S. 10 E. 16 Ch. to a stake on
Turpins line thence with his line S. 80 E. 17 Ch. to a chestnut, thence
S. 25 W. 24 Chs. with Turpins line to a stake, on the gap Creek
Road, thence an Eastwardly course with the road which is stan-
-dard line, also about 42 Chs. to a chestnut to William Johnsons
Corner thence N. with his line 15 Chs. to a stake by a sycamore
thence 8 Chs. the same course to a stake by a persimmon thence
N. 7. E. 15 Chs. to a hickory N. 83 W. 3 Chs. to the corner thence
