 Pollard of the district of Greenville in ^{the} State afo. have granted, barg-
 =ained sold, & released and by these presents do grant, bargain
 sell & release unto the s^d. J. A. Pollard all that tract or parcel of
 land containing one hundred & fifty five acres more or less
 lying in the district of Greenville on both sides of Pyles Branch
 Reedy River the said land being part of a tract originally
 granted Kenna Harrison & signed by his Excellency Benjamin
 Gerard on the 15th Oct 1784. and a part granted to hance black
 & signed by his Excellency Thomas Pinckney on the 1st Oct. 1787
 & a part granted to John Thomas J^r and signed by his Excellency
 Edw^d. Rutledge on the 5th Jan: 1799 & a part granted to John
 Pyle as reference to the Grant, beginning on a sweet Gum
 on the South side of the Reedy fork of Reedy River thence running
 Westward 39 Chains to a pine corner, thence S. Eastward to a
 Stake corner, thence running, five Chains and a half to Pyles
 branch, thence up said branch to a poplar stump near s^d. Benjn
 Pollards Mill, thence along a Conditional line to a Stake corner
