that tract or parcel of land lying in the district afo^r on both sides of
Enoree river it being part of a tract of lands granted to Robert
Goodlett known by the name of the Walnut Bottom beginning on
a red oak in Goodletts line thence running with said line to a
Stake corner on Goodletts line thence a conditional line made between
Gibson Southern & Martin Ayres to a Spanish oak corner on S. Ayres
line thence a conditional line between s^d Southern & Ayres to a maple
on the Still house branch thence to a poplar in Sias Calahams
line on a branch thence across the meanders of S^d branch to a maple
thence on with meanders of S^d branch to a white oak, thence to a
white oak, thence to a post oak on Calahams line thence along
Miles Southern line to a Maple thence a cross the river to a poplar
on the north bank of S^d river thence up the hill to a post oak
corner, thence to a hickory on finchey line, thence to a hickory
corner, thence to a Maple on the bank of the river thence up the Man-
-dus of S^d river to the beginning corner containing two hundred and
more or less to have and to hold all & singular the rights, members
