


State of South Carolina Greenville district, Know all men by these presents 298
presently that I Aaron Kemp of Greenville district & State afo. for the
Sum of three hundred & fifty dollars to him in hand paid by Street
Thurston of the district afo. hath Granted bargained Sold & released
and by these presents do Grant bargain sell & release unto the said
Street Thurston a certain Tract or parcel of land containing three
hundred acres more or less lying in the district & State afo. on the
North Side of Enore & on the S.E. Side of a branch called the Long
branch or upper line of P. Tract where beginning on a pine stump
running S. E. Course straight line to a black gum corner, thence to
a Stake corner on Bidwell's line thence said line S. 35. W. to Saunders
line, thence with S. line to a Chestnut corner on the upper line of said
tract, thence with the old line to the beginning, together with all &
Singular the rights members, hereditaments and appurtenances to
the S. premises belonging or in anywise incident or appertaining
to have & to hold all & Singular the premises before mentioned
unto the S. Street Thurston his heirs & assigns forever I do hereby
bind myself my heirs executors & administrators to warrant & defend
all and Singular the S. premises unto the said Street Thurston his
heirs or assigns against myself & my heirs & against every person
whomsoever lawfully claiming or to claim the same or any part
thereof as witness my hand and Seal this 18th day of August 1821

by Elias Barneth of the district & State afo. have granted bargai-
-ned & Sold and by these presents do grant bargain sell and
release unto the said Elias Barneth one tract or parcel of Land
containing six hundred & four acres (more or less) Situate & being
in the district of Greenville lying & being on Mountain Creek
Water of Saluda River. Beginning on a Stake running thence
S. 5 W. 3 Ch. to a Stake thence N. 85 W. 110 Chain to a red oak thence
N 8 E. 96 Ch. 50 lks. to a post oak thence S 85 E 15 Ch. to a red oak
thence S. 19. Ch. & 50 lks. to a red oak on the road leading by
Howell Sullivan's thence down the said road to the beginning
corner being part of the Tract commonly known by the name
