 of January 1801. beginning on a Red Oak thence North 55. Et. 44. 72  
 to a chestnut thence N. 29 Et. 15. 50 to a post oak thence N. 57 W. 19 to  
 a pine thence S. 60 W. 30 to a post thence S. 9 W. 38. 50 to the beginning  
 Together with all and singular the Rights, tenements, to the  
 said premises belonging or in any wise appertaining to have  
 and to hold the fore mentioned tract of one hundred acres more
