Crowder, Sheriff aforesaid, by virtue of the said writ of fieri facias aforesaid to me directed and delivered as aforesaid, as aforesaid, and by virtue of the statute in such case made and provided, and for and in consideration of the said sum of five hundred Dollars, to me in hand paid, or secured to be paid by the said Robert Anderson the receipt and payments whereof I do hereby acknowledge, have granted, bargained and sold, and these presents do grant, bargain and sell unto the said Robert Anderson, his heirs and assigns for ever, the said tract, piece and parcel of land, with its appurtenances, and all the estate, right, title and interest, which the said Adam Carruth of right had of in and to the same: To have and to hold the said piece parcel and tract of land, with its appurtenances unto the said Robert Anderson his heirs and assigns for ever, as fully and absolutely as the said Asa W. Crowder might could or ought to grant, bargain and sell the same, by virtue of the statute aforesaid, and the said writ of fieri facias of other wise, in witness whereof, I the said Asa W. Crowder have hereunto set my hand and seal, the second day of February in the year of our Lord one thousand eight hundred and Twenty four sealed signed and Delivered in the presence of
