South Carolina Know all men by these presents that I John Edwards <sup>293</sup> of  
 Greenville District and State aforesaid In consideration of the sum of  
 Sixty Eight Dollars to me in hand paid by Philip Meroney of the  
 State and District aforesaid the receipt whereof I do hereby acknowledge,  
 Have granted bargained sold released conveyed and confirmed and by these  
 Presents do grant bargain sell release convey and confirm unto the said  
 Philip Meroney his heirs or assigns a certain tract or parcel of land contain-  
 ing by estimation <sup>sixty</sup> acres be the same more or less situate in Greenville District  
 aforesaid on the Branches of the North fork Saluda River and runs or follows  
 That is to say beginning on a Hickory thence SSW  $\frac{1}{8}$  to a pine thence S. 15.  
 E. 9 to a Stake on Stamford's line thence with said Stamford's line to a small  
 Branch that runs through William Shelton's field thence up said Branch  
 To the fork thereof thence up the west or left hand fork to the head in  
 an old field thence up hollow to a stake on the ridge thence down the  
 hollow over the ridge a North westerly course to the head of a small  
 Branch thence down said Branch to a conditional marked line orig-  
 inally made between Marson and Albert T. Smith thence with said cond-  
 itional to the Beginning being part of a large survey granted to Rob-  
 ert Prince by a grant bearing date the seventh day of March one thou-  
 sand seven hundred and Eighty seven together with all and singular the  
 Rights members hereditaments and appurtenances to the said Premises  
 Belonging or in any wise incident or appertaining thereunto and to  
 hold all and singular the premises above mentioned unto the said Philip  
 Meroney his heirs and assigns forever and I do hereby bind myself  
 My heirs Executors and administrators to warrant and forever defend the  
 premises above mentioned unto the said Philip Meroney his heirs Executors  
 administrators or assigns against myself my heirs Executors and adminis-  
 trators and against all and every other person or persons whom  
 soever lawfully claiming or to claim the same or any part thereof.
