 of thirty dollars to me in hand paid by Robert Dockery both parties of
 The S. D. District aforesaid have bargained & sold unto said Dockery
 a certain tract or parcel of land lying and being in the District a-
 foresaid on the north of hogback mountain Beginning on a stake on
 George Belus line thence N 86. W. to a Chestnut thence N 43.8 E. to a
 Hickory thence S 87 W. 20. to a large white oak thence S 2. 55 W. 11. to a Rock
 thence S 72. 2. 7 Ch. to a Chestnut oak thence a strat line to a branch the
 Head of mowdour mill creek concluding the branch to be the line between
 the Robert Dockery & Drewry Hooker thence running from the Branch to
 Belus line thence along the line to the beginning corner supposed
 to be one hundred acres more or less being a part of a survey granted
 to James Cockram the 7th of April 1817 together with all and singu-
 lar appertinences there unto belonging or in any wise incident to have
 and to hold for which so. tract of land I warrant and forever defend
 unto him the said Robert Dockery his heirs and assigns D. B. forever a-
 gainst my self my heirs or assigns, I do her by warrant and forever
 defend from all persons or persons claiming or to claim the same
 there of Witness my hand and seal this twenty second day of
 Feb. and in the year of 1822 and in the forty sixth year of Ameri-
 can independance signed sealed & Delivered in the presence
