to a poplar then S. 55 E. 36 chain to Gum then S. 45. E. 2 chain 50 links
to the beginning Post oak and containing One hundred and ten acres
Be the same lying in the District of Greenville and lying on waters of little
Reedy fork together with all and singular the rights members hereditaments
and appertanances to the sd lands belonging or in any wise Incident or
appertaining to have and to hold all and singular the lands before mentioned
unto the sd Adam Jones and his heirs and I bind myself and
my heirs Executors and Administrators to warrant and for ever defend
all and singular the sd lands to the sd Adam Jones his heirs and assigns
