Alexander administrators of the estate of David Peden Decd late of the State & District of aforesaid in conformity with an Order of the Court of Common Pleas of the District of aforesaid in consideration of forty five dollars to us paid by James Martin of the State & District of aforesaid have granted bargained & sold & released & by these presents do grant bargain sell & release unto the said James Martin a certain tract or parcel of Land containing Seventy five acres situated in State & District of aforesaid on the waters of Raybourns creek being a part of a tract Originally granted to David Peden containing nine hundred & ten acres granted by his Excellency Charles Pinckney the 2nd day of March 1792. Beginning on a rock 37 running thence 50 E. 30 to a Stake thence N. 24 to a Stake 37 thence W. 22 to a Stake 37 thence S. 44 to the Beginning together with all & singular the rights & members hereditaments & appurtenances to the sd premises belonging or in any wise incident or appertaining to have & to hold all & singular the premises before mentioned unto the sd James Martin his heirs & assigns forever and we do hereby bind our selves as administrators of the Estate of David Peden Decd to warrant & forever defend all & singular the sd premises unto the sd James Martin his heirs & assigns against our selves & the heirs of David Peden Decd lawfully claiming or to claim the same or any part thereof. Witness our hands & seals this seventeenth day of December in the year of our Lord eighteen hundred & twenty four & in the forty eight year of American Independence.
