 of Two hundred & fifty Dollars to me paid by John Otts of Spartanburg
 District have granted bargained sold and released and by these
 presents do grant bargain sell & release unto the said John Otts a tract
 or plantation of Land lying and being in the District of Greenville
 aforesaid on both sides of Greens Creek a branch of South S^c Carolina
 River Beginning at a Red Oak near a branch (Stephen Johnsons corner
 running thence N. 22 Ch. to a White Oak thence S. 60 W. 26 Ch. to a
 Forked Chestnut thence N. 10 E. 36 Ch. to a stake thence N. 48 W. 10 Ch. to a
 Hickory (John Evans corner) thence N. 10 E. 32 Ch. to a large poplar thence
 N. 25 E. 12 Ch. to a stake thence S. 70 E. 50 Ch. 50 links to a stake -
 Stephen Johnsons corner, thence a straight line nearly a
 S. course with Stephens line to the head of the nearest branch then
 down the meanders thereof to the creek thence up one other branch that
 emptys in on the S. & other side to the beginning containing by estimation
 three hundred acres be the same more or less being a part of a tract
