This Indenture Made the second day of January One thousand Seven Hundred and ninety six Between John Melin of Greenwell County & State of South Carolina of the one part and Richard Young of the County & State aforesaid of the other part witnesseth that for And in consideration of the Sum of five pounds in hand paid the Receipt whereof is hereby acknowledged the said John Melin hath granted Bargained Sold & Conveyed and by these presents do hereby Grant and Convey to the sd Richard Young his heirs & assigns a tract or parcel of land being part of a tract originally granted by the sanction of South Carolina to John Combes beginning on a Maple corner on William Goodlets line thence N. 41 W. to Post oak corner, then S. 60. W. to Post oak corner then S. 40 W. to a conditional black oak Co. then by a conditional line to a post oak Co. between sd Richard Young & Sean Evans thence to the beginning including all in them boundaries the same more or less to have and to hold the aforesaid Land with all the appertinances thereunto belonging by him the said Richard Young his heirs & assigns for ever, and the sd John Melin do for him self his heirs or assigns or any of them hereby do warrant and forever defend the aforesaid Land from the just claim of him self his heirs and all other demands whatsoever to the said Richard Young his heirs and assigns In testimony whereof I have hereunto set my hand and seal the days year above written signed sealed & delivered in presence of us Wm Anderson J.
