To have and to hold the said piece parcel and tract of land, with its appurtenances, unto the said Jeremiah Cleveland his heirs and assigns for ever as fully and absolutely as I the said Nimrod Underwood might could or ought to grant, bargain and sell the same by virtue of the Statute aforesaid, and the said writ of fieri facias or other writs.
