Know all men by these presents that I Allan R. Parkins of the district and State aforesaid for and in consideration of the sum of one dollar to me in hand paid by Joseph P. LaBruce have given permitted and authorized and by these presents do give, permit and authorize the said Joseph P. LaBruce to cut, open and clear out a road through my land, leaving the road leading from Greenville Court House to the Fork Shoals on Rudy River west of my House and a short distance from it, and running on my land directly to the said LaBruce's Mill on Rudy River and thence to Greenville Court House and the same to keep open cleared out, use occupy and enjoy to him and his Heirs and to every other person whomsoever free from any let hindrance or disturbance from me or my heirs assigns Executors or Administrators But it is expressly understood that no right or title to the land is hereby given or conveyed or any thing else but the Right of way over and across the same as far only as is necessary the said Road shall run on my land and to run so that the same shall not be changed to my great injury without my Consent. Witness my hand and seal this sixteenth day of October A.D.

Know all men by these presents that I James Stewart of Greenville District in the State aforesaid in consideration of the sum of two hundred and fifty paid by Harden Roberts of Greenville District in the State aforesaid have granted bargained sold & released & by these presents do grant bargain sell & release unto the said Harden Roberts all that tract or parcel of land supposed to contain one hundred and fifty acres be the same more or less situate in Greenville District aforesaid on the South side of Clear Creek beginning at the mouth of Gum branch running up the Branch to a stake corner from thence continuing up the branch to a white oak corner from thence to stone all corner at stake from thence along a conical line to a maple corner on the Creek from thence down the Creek to the beginning together with all and singular the Rights members hereditaments & appurtenances to the said premises bearing or in anywise incident or appertaining to have and to hold all & singular the premises before mentioned unto the said Harden Roberts his heirs & assigns for ever & I do hereby bind myself, my Exrs. & admors to warrant and for ever defend all & singular the said premises to the sd. Harden Roberts his heirs and assigns against myself & my heirs & against every other person or persons whomsoever ever lawfully claiming or to claim the same or any part thereof Witness my hand this 6th day of February in the year of our Lord one thousand eight hundred and twenty seven signed sealed & delivered in presence of
