




South Carolinae ³ Know all men by these presents that we
 Greenville District ³ James Ross and Daniel Ross of aforesaid State
 and District do bargain sell and deliver James Akin all that tract of
 land or plantation in Greenville District on the North side of the Beaverdam
 Creek a branch of middle Tyger River being the place where Daniel Ross
 generally lived begining on a chestnut on Thomas Stanfords line on the
 bank of the Creek and running thence N. 37° E. 5 chains to a pine thence
 N. 30° W. to a black oak on Turpins line thence with his line S. 42° W. 27.
 ch 50 links to a stake thence N. 48° W. 5. chains to a stake thence N. 21° E. 21 ch 50. links to a post oak stump thence S. 2. W. 25 chains to a hickory
 grub near the wagon road thence S. 4. 7 W. 25. ch to white oak on the
 bank of the Creek and thence down the meanders of same creek to the
 begining Containing by Estimation ninety acres be the same more
 or less being all the part of a tract of 379 acres of land that lays
 on the North side of the Creek which was given by James Ross to
 Daniel Ross and the said James Ross purchased the said land
 from John Burk together with all and singular the rights —
 members hereditaments and appurtenance to the premises belonging
 or in any wise appertaining To Have and to Hold the above men-
 tioned premises unto the said James Akin his heirs and assigns for
 ever and we do hereby bind ourselves our Heirs and Executors to warrant
 and defend the above mentioned premises unto the said James Akin
 his heirs and assigns against us and our heirs & against person
 or persons whomsoever lawfully claiming or to claim the same or
 any part thereof In witness whereunto we have set our hands and
 seals this the 4 of December A.D One thousand eight-hundred and
 twenty six and fifty first year of American Independence
 signed sealed in presence of ³ James ^{his} Ross.
