E. by John Clements land and originally granted to Daniel Wilbanks Together with all and singular the rights members hereditaments and appurtenances to the said premises belonging or in any wise incident or appertaining To Have and to Hold all and singular the Premises before mentioned unto the said Lemuel Loftis his heirs and assigns forever and I do hereby bind my self my heirs Executors and administrators to warrant and for ever defend all and singular the said premises unto the said Lemuel Loftis his heirs and assigns against myself and my heirs and against Every Person whatsoever lawfully claiming or to claim the same or any Part thereof Witness my hand and seal this ninth day of April one thousand eight hundred and twenty seven And in the fifty first year of the Independence of the United States of America signed sealed and delivered in presence of
