 and to be taken in charge by him for the use of said Infant while
 Raising to let the Mother have the use of it and at the proper and law-
 ful age be given up by my trustee to the said Francis a McClain in
 in Testimony of this gift I here unto set my hand and seal this Eighteenth
 day of January in the year of our Lord 1827.

 ed and sold and by these presents do grant bargain and sell and deliver unto the
 said Jesse Mayfield a plantation or tract of land lying in the district of Greenville
 and State of South Carolina marked as are represented by a plot beginning on
 a Red oak on Josiah Williams line to a white oak on a line a River then
 thence to a State & thence to a white oak on a line then for Thomas Ri-
 sner, thence to the dividing line which was the beginning to contain sixty
 acres more or less Together with all and singular the Rights members here-
 = delaments and appurtenances therunto belonging or in any wise incident
 or appertaining to have and to hold all and singular the above
 mentioned premises unto the said Jesse Mayfield his heirs
 and assigns against myself my heirs and assigns and hereby
 warrant and defend the same against myself my heirs Executors ad-
 = ministrators and assigns and against myself & all persons or persons whom
 so ever lawfully claiming or to claim the same or any part thereof
