waters of Saluda River. Beginning on Corners old line S. 10. E. 28. 50 to a P.O.
S. x thence N. 85. E. 42 to a Stake S. x. thence N. 5. W. 20. to Corners old line thence N. 85.
W. 45. on Corners old line to the Beginning. Together with all and singular the
Rights, members, hereditaments and appurtenances to the sd premises belonging or
in any wise Incident or appertaining to have and to hold all and singular
the premises before mentioned unto the sd John Whitt his heirs and assigns
for ever and I do hereby bind myself my heirs Executors and administrators
to warrant and for ever defend all and singular the sd premises unto the
sd John Whitt his heirs and assigns against my self and my heirs and against
every person whomsoever lawfully claiming or to claim the same or any part
thereof - as witness my hand and seal this thirty first day of May one
thousand eight hundred and twenty one and in the forty fifth year
of the Independence of the United States of America signed sealed
and delivered in the presence of
