

The State of South Carolina. To all to Whom these presents shall come
 I Nimrod Underwood Sheriff of Greenville District in the State aforesaid
 do send greeting whereas in pursuance of a writ of Partition issued out
 of the Court of Common Pleas for the said district of Greenville at the instanc-
 -e of Enoch B. Benson and wife for the partition of the lands and real
 Estate of Genl. John Blasingame dec'd between and among his heirs at Law, Commis-
 -sioners appointed therein made their return to the said writ sitting fourth
 -ed to sell the whole of the said lands and real Estate at public aucti-
