 Branch to a conditional corner on a ash thence a strait line to
 one more conditional corner to a post oak on the other line thence
 N. 20. W. to the beginning corner on the red oak the same being a part
 of a tract of land granted to the dick Murry and said Murry sold
 and conveyed to Labon Loftis and by said Loftis sold and conveyed
 Archer Holcomb and by said Holcomb sold and conveyed unto John
 Leese and by sd Leese sold and conveyed unto the above Benj
 amin West Junr and by the sd Benjamin West Junr sold and conveyed
 unto the above Benjamin West Junr containing one hundred acres be
 the same more or less including the improvement whereon sd B. West
 Junr now lives Together with all and singular the said premises
 Rights members Hereditaments and appertinances there belonging or
 in any wise appertaining to have and to hold all and singular the
 sd premises before mentioned unto the said Benjamin West Junr his heirs
 and assigns for ever and I do hereby bind myself my heirs Executors and ad
 ministrators to warrant and for ever defend all and singular the said
 premises unto the said Benjamin West Junr his heirs and assigns against
 myself my heirs and assigns all and every other person whomsoever lawfully
 claiming or to claim the same or any part thereof In witness whereof
