 thence down the meanders of said Creek to the beginning containing Eight
 and a half acres of land for the same more or less Together with all and singu-
 lar the rights minibus hereditaments and appurtenances to the said prem-
 ises beloning or in any wise incident or appertaining to have and to hold
 all and singular the premises before mentioned unto the said Daniel F.
