



W. Dumas an Greenville District } of the Justice assigned to keep the Peace Henry Smith & made oath in due form of law & faith on his oath he saw James Heitt assign the within deed to Robert Clark for the purpose therein mentioned & he the said Henry Smith saw Isaac Heitt with himself assign the same as witnesses thereto sworn to before me this 26 May 1828.

William Heitt a certain plantation and tract of land originally granted to Benjamin Farmer on the third day of March one thousand eight hundred thence conveyed to James Heitt and then from him to sd. Robert Clark now from sd. Clark to sd. William Heitt, situated in sd. State and District lying on the Ruddy Fork waters of Ruddy River Beginning on a red oak 37 thence S. 60. W. 46. ch. 50 L to a Stake 37 thence N. 45. W. 14 E 50. to a P.O. 37 thence N. 75. W. 21 ch. to a R.O. 37 thence N. 20. W. 13. ch. to a R.O. 37 thence N. 75. E. 21. ch. to a black gum in a big swamp 37 thence N. 20 E. 33. ch. to a Stake 37 thence N. 20. W. 16 ch 50 L to a Stake 37 thence N. 60. E. 26 ch to a Stake 37 thence to the beginning containing three hundred and ninety seven acres more or less including the plantation where George Heitt formerly lived together with all and all and singular the rights, members hereditaments and appurtenances to the said premises or in any wise incident or appertaining to have and to hold all and singular the premises before mentioned unto the said William Heitt his heirs and assigns for ever against myself my heirs Executors and administrators and no other person whatever Witness my hand and seal this seventh day of February one thousand eight hundred and twenty five and in the forty ninth year of the Independence of the United States of America signed sealed and delivered in presence of
