 ing on a Spanish Oak 3^t running thence N. 55 W. 15.50 to a Stake 3^t bound-
 ding on John Gambley land, thence S. 46 W. 9.50 to a Stake 3^t thence
 43° E. 24.00 to a dogwood 3^t bounding on the said John Bagwell
 land thence N. 50 E. 15.00 to a Stake 3^t bounding on Mason Nabours
 land thence N. 55 W. 6.40 to a red oak 3^t thence S. 65 W. 5.25 to a Stake 3^t on a
 branch thence up the meander of said branch to the beginning together with
 all and singular the rights, royalties, hereditaments, and appurtenances to the
 same belonging or in any wise incident or appertaining to have and
 to hold all and singular the premises before mentioned unto the said
 William Bagwell his heirs and assigns forever and I do hereby bind my self my heirs
 Executors and administrators to warrant and for ever defend all and singular the said
 premises unto the said William Bagwell his heirs and assigns against myself and my heirs
 and against every other person whomsoever lawfully claiming or to claim the same or any part
 thereof Witness my hand and seal this twelfth day of August in the year of our Lord
 One thousand eight hundred and twenty eight and in the fifty third year of the Inde-
