 Whereas in pursuance of an order from the Court of Ordinary for Greenville
 district at the instance of Elizabeth Turner for the sale of lands and real

 Benjamin Turner deceased, after public notice thereof Now Know Ye

 Elizabeth Turner her heirs and assigns for ever as fully and absolutely as I the Sheriff as afo-
 -said might could or ought to grant bargain and sell the same, by virtue of
