 two hundred dollars to me in hand paid by Thomas B. Williams  
 of the same district and State Have given, granted, bargained  
 and sold and do by these presents give grant bargain and sell to  
 the said Thomas B. Williams all that tract of land lying on the  
 Golden Grove Creek in the district and State aforesaid,  
 containing Two Hundred and thirty one acres more or less  
 Beginning on an ash on the Grove Creek running thence S. 64. E. 2  
 7/8 chains to a maple thence N. 76. E. 22. chains to a maple thence  
 S. 84. E. 11.5 ch. to a B.O. thence N. 36. 11.08. chains to a dogwood thence  
 N. 80. E. 24. 75 ch. to a persimmon thence S. 49. E. 6. 67 ch. to a post  
 Oak thence S. 25. W. 67 ch. a long Rice, Cox and Mary Sea born  
 lines to a black Oak thence N. 45. W. 63.5 ch. to said Grove  
 Creek thence up the middle of the said Creek to the begin  
 ing SO. Have and to hold said tract of land together  
 with all and singular the rights members hereditaments  
 and appurtenances thereunto belonging or in any wise  
 incident or appertaining to the said Thomas B. Williams  
 his heirs and assigns forever and I do hereby bind myself my  
 heirs Executors and administrators to warrant and forever
