E. 21.50 to a pine 3x thence S 73 W. 13.50 to a stake 3x thence South 4 ch to a pine 3x thence S. 25. E 49.50 to a small P.O. 3x thence N. 60. E 81. etc a crop the State Road to a B.C. 3x thence N 46 W 16.75 to a pine down or small P.O. 3x new thence S 89 W. 21.75 across the State Road to a chestnut 3x thence N. 25. W. 7.4 ch across the State Road to a B.
