 of the other part Whereas Andrew Johnson and Eliza his wife late Eliza
 Bryner in their own right and as Guardians an or a baught the twen-
 ty fifth day of June 1827 did Exhibit their bill of Complaint
in the Court of Equity at Greenville Court House in the said State a-
gainst Samuel B. White and Nancy E. White late Nancy E. Bryner's
and Thamar Bryner administrators and Guardians stating that William
M. Bryner decd Intestate seized and possessed of a valuable real
Estate leaving the said Nancy E. his widow and John D. George W.
Martha N. Thamar P. Mary A. and William M. Bryner and Eliza wife of the
said Andrew Johnson heirs at Law him surviving and prayed for parti-
tion of the said real Estate according to their rights, and the cause
being at issue before the Honorable Court came on to be heard at
