Greenville District } cliff of the Dist & State aforesaid for & in consideration  
of the sum of one hundred & seventy five dollars to me in hand paid by  
Edward Croft the receipt whereof is hereby acknowledged Have granted  
bargained & sold by these presents do give grant bargain & sell unto  
Edward Croft his heirs and assigns for ever a certain tract of Land lying  
& being in the Dr & State aforesaid & containing One hundred & thirty acres  
be the same a little more or less & being all that tract of land which was  
some years ago sold & conveyed to Isaac Wickliff & his heirs by Joseph  
Langston butting & bounding as follows beginning at a Post Oak corner at  
a path leading from said Langtons to where Hardy Roberts formerly lived  
& running from thence S. 60. E. 15. Chains to a post Oak corner of said  
Edward's Land 150. Chains & 70 links, to a red oak corner a corner of Lan-  
gtons old survey thence N. 30. E. 53. Chains & 50 links to a black Gum thence  
N. 31. chains & 50. to a red oak corner on Roberts line thence with said line N. 30  
W. 21. Chain to a stake in center of thence red oak near the said path from thence  
to the beginning containing one hundred & thirty acres be the same a little  
more or less & which is more fully represented by a plat hereto annexed  
& made part hereof To HAVE & to HOLD the said tract of Land together  
with all & singular the rights, numbers incidents & appertinances thereto  
belonging or in any wise incident or appertaining thereto and of the  
said W. E. Wickliff do hereby bind my self & my heirs, Executors & assigns to  
warrant & for ever defend all & singular the premises & appertenan-  
ces herein & hereby bargained & sold to the said Edward Croft & his  
heirs forever from & against myself & my heirs & Exors and also  
from & against all persons or person whomsoever claiming or to  
claim the same or any part or parcel thereof. In testimony whereof
