 we Benjamin Allston of Georgetown, Planter, and Martha Hays Pyatt als of
 Georgetown widow, for and in consideration of the natural love and affection
 which we have and bear to Martha Louisa Fredrica Maldin, wife of William
 Mauldin of Greenville in the same State aforesaid and also for divers other
 good causes and considerations us thence moving. Have given granted
 and confirmed, and by these presents, Do Give Grant and confirm unto
 Jeremiah Cleveland and Samuel Grayton of Greenville in the said State
 The following negro slaves, to wit Frank, Ellen, Andrew, Rosena,
 Nero and Mary together with the future issue and increase of the females
 To Have hold and enjoy all and singular the aforesaid negro slaves, together
 with the future issue, and increase of the females unto the said Jeremiah
 Cleveland and Samuel Grayton their Executors Administrators and assigns
 forever In trust never the less for the joint-use of the said William
 Maldin and Martha Louisa Fredrica his wife during their joint
 lives not-subject to the debts of the said William Maldin and after
 the death of either of them In trust for the use of the survivor
 of them during his or her natural life, not-subject to his or her
 debts, and from and immediately after the death of the survivor of
 of them In trust for the use of all and singular the child or
 children of the said Martha Louisa Fredrica, and in default
 of children child or issue of the said Martha Louisa Fredri-
 ca then and in that case that the said negro slave, together with
 the future issue and increase of the females, vest absolutely and
 forever in the survivor of them the said William and Martha
 Louisa Fredrica his or her Executors Administrators and assigns
 In witness whereof we the said Benjamin Allston and Mar-
 tha Hays Pyatt have hereunto set our hands and seals this
 fifteenth day of December in the Year of our Lord one
 thousand Eight Hundred and twenty seven and in the fifty
 second Year of American Independence signed, sealed and
 delivered in presence of
