 the beginning including ninety one acres together with all and singular the Rights  
 mem bers hereditaments and appurtenances to the said premises belonging or  
 in any wise incident or appertaining to have and to hold all and singular  
 the premises before mentioned unto the said Elias Fincher and his heirs and assigns  
 my self my heirs Executors and administrators to warrant and for ever
