 of Geo W. Earle, deceased of Greenville district and State aforesaid for
 and in consideration of the sum of seven hundred dollars to me in hand
 paid by Elias D. Earle of the district of Greenville and State aforesaid
 Have granted bargained, sold and released, and by these presents
 do grant bargain, sell and release unto the said, Elias D. Earle two certain
 lots of land containing One Acre be the same more or less, situated lying
 and being in the district and State aforesaid in the Village of Greenville
 Known & distinguished in McBurn plan or chart of said Village by the
 numbers, thirteen (13) and fifteen (15). Beginning at a stake corner on
 the west side of main street running thence and fronting the said
 street South sixteen degrees west two hundred feet to a stake thence
 North seventy four degrees west two hundred and thirty five feet
 to a stake on Laurens street thence a long and fronting said street
 North sixteen degrees East two hundred feet to a stake on the corner
 of Laurens and Washington streets thence South sixty four degrees East and
 along Washington street two hundred and thirty five feet to the beginning
 as may more fully appear by reference to the aforesaid plan of
 the village. Together with all and singular the rights, members, heredita-
 -ments and appurtenances to the said premises belonging or in any
 wise incident or appertaining. Do Have and to Hold, all and
 singular the said premises unto the said Elias D. Earle his heirs and assigns for ever
