




Hardy J. Gilreath, Alfred Gilreath, Rolly Jenkins, Owen Jenkins Vincent Jenke

 the United States of America. And in further trust and confidence, that they
 shall at all times forever hereafter, permit such Ministers, belonging to the said
 Church, as shall from time to time be duly authorized by the General confere-
 = ces of the ministers and Preachers of the said Methodist Episcopal Church
 or by the Annual conferences authorized by the General Conferences, to
 preach and Expound Gods Word therein. And the said parties, do
 by these presents, warrant and forever defend all and singular the
 before mentioned and described lot or piece of land with the appur-
 = tenances thereto belonging, unto them the said parties of the second
 part, and to their successors in office chosen and appointed accord-
 = ing to the Statute of the State of South Carolina in such case made
 and provided, from the claim or claims of them the said parties of
 the first part their heirs or assigns and from the claim or claims of
 all persons whatsoever. In witness whereof, the said parties of the first
 part have hereunto set their hands and seals the day and year first
 above mentioned, Sealed and delivered in presence

 = roa Underwood Sheriff of Greenville District and State aforesaid, send
 Greeting: Whereas by virtue of a writ of Fieri Facias issued out of the Court of
 Common Pleas, held for the District aforesaid & tested the seventh day of November
 in the year of Lord one thousand Eight hundred and twenty five at the suit
 of Chesparwister & Co against Alexander Sloan surviving copartner of the
 late firm of Crayton & Sloan to me directed, commanding me, that of the
 goods and chattels, lands and tenements of Alexander Sloan surviving co-
 = partner of Crayton & Sloan to buy the sum of fifteen hundred and
 forty nine dollars damages and costs, I have seized and taken of the lands
 and tenements of the said Alexander Sloan surviving copartner of Crayton &
