 Middle Tyger River. Beginning at Maple on the North bank
 of the River thence N. 7 E. 4 ch. to a Birch thence N. 17 W. 7 ch. 62
 lbs. to a stake to a road thence with the Road N. 50 E. 2 ch. thence
 N. 25 E. 2 ch. 30 lbs to a ditch thence N. 55 E. 4 ch. 50 lbs to a small
 Walnut x 3 thence N. 24 E. 13 ch. to a post sapline near a branch thence
 N. 8 E. 45 ch. 50 lbs. to Red oak corner thence N. 80 E. to a red oak
 corner on the North side of the Goodgion Road thence S. 16 W. a cross
