 up said stream and corner to a large pine on the Edge of the stream thence to  
 the Beginning Including Twelve acres more or less Together with all and singular  
 the rights members Here detements and appurtenances to the said premises  
 Belonging or in any wise Incident or appertaining to have and to hold all  
 and singular the premises above mentioned unto the said Richard Scruggs his  
 heirs and assigns forever and I do hereby bind myself my heirs Executors  
 administrators and assigns to Warrant and forever defend all and singular  
 the said premises unto the said Richard Scruggs his heirs and assigns against  
 myself my heirs and every person whomever Lawfully claiming the same  
 of any part thereof as witness my hand and seal this 2<sup>nd</sup> day of January
